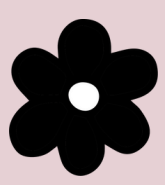
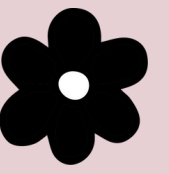

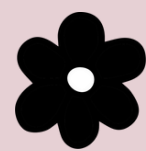


# DERMATOSURGERY AND PROCEDURAL DERMATOLOGY

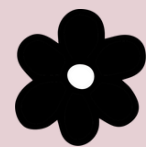


Will include guidance regarding all queries of the students regarding clinic/opd management, treatment of patient, various dermatology procedures and surgeries.

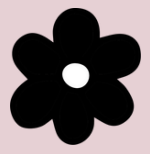

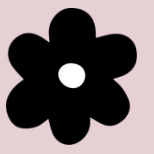
## RULES AND REGULATIONS



- Duration of observership will be for 1 month , 30 days from 1st of each month
- Clinic timings shall be strictly adhered to, which is from 10.00 a.m. to 7.00 p.m. (Monday to Saturday)
- Clinic will remain closed on Sunday
- Enrolment charges for the program will be Rs 2,75,000/- +gst of which 25000/- has to be deposited to confirm your position and will be non-refundable.
- (Bank account details given below)
- You will be allowed to observe all procedures in the OPD, though a commitment to cover all procedures/ surgeries in a span of 30 days cannot be given, as it is subjective
- Shivani skin clinic preserves all rights of admission and cancellation at any time.
- Seats would be given only on first come first serve basis.
- Apron/labcoat is compulsory.
- Accommodation has to be managed by the students, though we can help finding a satisfactory place.
- Seat would be confirmed only after paying registration amount.
- Students would receive certificates after completion of observership program.
- Students are required to follow and maintain the discipline and harmony at the institute.
- 90% attendance is compulsory without which completion certificate will not be issued.
- All property, products, instruments and consumables should be handled with care.
- Cooperation and participation towards patient care is expected.
- Any act against the institute shall be considered as act of indiscipline and student can be dismissed at any time from the institute.

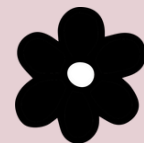
